IMPORTANT PRIVACY CHOICES FOR CONSUMERS**

You have the right to control whether we share some of your personal information. Please read the following information carefully before you make your choices below.

Your Rights

As described in our Privacy Notice, you have the right to restrict the sharing of personal and financial information with our Affiliates (companies we own or control) and with certain outside companies with which we do business. In addition, you also have certain rights to limit the marketing that you receive. Nothing in this form prohibits the sharing of information as provided in our Privacy Notice. For example, we will still be permitted to share information: (1) necessary to follow the law, (2) as permitted by law, or (3) to provide you the best service on your accounts with us. This includes sending you information about some other products or services.

Your Choices

Unless you say “No,” the Credit Union and its Affiliates will continue the following information-sharing and marketing practices:

1. The Credit Union and its Affiliates may share personal and financial information about you with outside financial institutions with whom we have joint marketing agreements to provide their financial products and services to you.
2. The Credit Union and its Affiliates may share “Other Information” (for example, credit reports) with each other.
3. The Credit Union’s Affiliates may use your personal and financial information to directly market their products and services to you.
