2. By certified mail, if you have previously provided identification in a written request that your file be sent to you or to a third party identified by you.

3. By telephone, if you have previously provided proper identification in writing to Agency. Agency has trained personnel to explain any information in your file to you and if the file contains any information that is coded, such will be explained to you.
